Thank you for your request of 30th December 2017. You requested the following information:

I am writing in the hope that you may be able to answer a query about timetable alterations on London Midland trains, which have in part been indicated are due to engineering work.

I have contacted London Midland directly, however as a private company they are not subject to the Freedom of Information Act. Furthermore, as my queries relate to engineering work undertaken by you, I hope you will be able to answer my Freedom of Information questions.

1. There were amendments made to the London Midland evening schedule on 06/12/2016-08/12/2016 inclusive, from London Euston to Bletchley. The 22:24 was not running, and I was informed by Alastair Cook, in the London Midland Customer Relations dept that "In our printed timetables for the Euston line there is a general note to warn those travelling with us that late night engineering work is carried out from time to time." Could you please inform me what engineering work took place over these three nights?

2. There are amendments made to the evening schedule this week, 28/12/2016-30/12/2016 inclusive, from London Euston to Bletchley. The 22:07, 22:24 and 23:04 services are not running. If this is due to engineering work, could you please inform me what work took place? I have processed your request under the terms of the Freedom of Information Act 2000 (FOIA).

I can confirm that we hold the information you requested. Work was carried out on 20 occasions from the 6th- 8th December 2016 and 10 occasions from the 28th-30th December 2016. The details of the engineering work that took place during these periods are included in the attached reports.

It may also interest you to note that every 12 weeks the line from the south of Northampton is blocked off to allow for maintenance to be undertaken. The last time this occurred was the week beginning the 5th December 2016. The next disruption will be the week beginning the 27th February 2017.

Please note that the attached reports cover the parameters of your request and more (I.e. outside the area designated in your request).

Where this distance cannot be obtained, the detonator protection must be placed at the greatest distance possible from the signal (or points or through crossings) concerned.
