"Please could i request an up to date list of all contractors, subcontractors and suppliers that have or will be involved with the development of the **Thameslink Programme**, originally **Thameslink 2000**, the a £6 billion project in south-east England to upgrade and expand the <u>Thameslink rail network</u> to provide new and longer trains between a wider range of stations to the north and to the south of London without requiring passengers to change trains in London."

"Please could I request an up to date list of all contractors, subcontractors and suppliers that have or will be involved with the redevelopment of Bristol Meads Station"

I have processed your requests under the terms of the Freedom of Information Act 2000 (FOIA) and I can confirm that we hold some of the information requested.

In regards to the information requested for Bristol Meads Station, I have consulted with our business experts and I can confirm that we do not hold the information requested. To explain, I am given to understand that no work has commenced on the BTM (Bristol Temple Meads Station) redevelopment project.

By way of assistance, I can inform you that funding should be forthcoming in CP6 (from 1/4/19) following which options will be considered and design work undertaken.

The delivery entity (which may not be Network Rail) will then have been agreed. The information requested may be available mid to late 2019 if you would like to make a new request at that point in time.
