I have processed your request under the terms of the Freedom of Information Act 2000 (FOIA) and I can confirm that we hold some of the information you requested.

I have consulted with our human resources specialists and they have confirmed that Network Rail only holds the data for 'part a' for each of the questions listed in your request, we do not hold the data as described in your request for parts b-d.

Please find below a table in answer to your request, which contains the redeployment information that you have asked for relating to all "disabled" and "non-disabled" employees at Network Rail.

In regards to the redeployment data for all signallers across Network Rail and for signallers employed solely on the LNW route, we do hold this information but it is exempt from disclosure under section 40(2) of FOIA. If we were to disclose the information, there is a risk that individuals may be identified, due to the small number of people which fall into this category. To explain, this is because the figures in question relate to five or fewer individuals in particular categories.

Section 40(2) of FOIA allows us to withhold information if it constitutes the personal information of identifiable individuals, and its disclosure would contravene one or more of the data protection principles of the Data Protection Act 2018.

The first data protection principle states that personal information must be handled fairly and lawfully. In our view disclosure of the withheld information would be unfair to the individuals concerned; where such small numbers are involved, the individuals would not reasonably have expected that such information would be disclosed. It is also important that the posts mentioned are not public-facing and are relatively junior within Network Rail's banding structure.

There is a legitimate interest in how Network Rail manages the redeployment of its employees including those with disabilities however; I consider that this interest is met by the disclosure of the rest of the requested information in this case.
